## Economic

### Industry Growth Program

**Agency:** Australian Government- Business

**Closing:** Ongoing

**Eligibility:** Innovative small and medium enterprises undertaking commercialisation and/or growth projects within the National Reconstruction Fund (NRF) priority areas:

- value-add in resources
- value-add in agriculture, forestry and fisheries
- transport
- medical science
- renewables and low emissions technologies
- defence capability
- enabling capabilities.

The program supports innovative small and medium enterprises undertaking commercialisation and/or growth projects within the National Reconstruction Fund priority areas through advisory services and opportunities for matched grant funding. Minor changes or improvements to existing products or services are not considered innovative.

The successful applicants will be connected to an Industry Growth Program Adviser who will provide tailored advice to support commercialisation and/or growth project.

Once this advice has been received, it is possible to apply for:

- grants of \$50,000 to \$250,000 to support early-stage commercialisation projects
- grants of \$100,000 to \$5 million for commercialisation and growth projects.

### Seed Start Program

**Agency:** Australian Government – Department of Infrastructure, Transport, Regional Development, Communications and the Arts

**Closing:** Ongoing

**Eligibility:**

- be a company incorporated in Australia with an active Australian Business Number (ABN)
- be a non-tax-exempt business
- be registered for goods and services tax (GST)
- have an annual turnover of less than \$1 million for each of the 3 financial years prior to the lodgement of their application
- be based or willing to be based in SA prior to commencing the project.

The Seed-Start program provides financial support for early-stage and high-growth potential businesses in South Australia. Eligible start-ups can apply for funding to assist with the cost of commercialising a product or service that is unique and has a sustainable competitive advantage in national and international markets. Two different funding types are available, depending on each business' stage of development:

- Seed Grants: Minimum \$50,000, maximum \$100,000
- Start Grants: Minimum \$100,001, maximum \$500,000

## Regional Precincts and Partnerships Program

**Agency:** Australian Government – Department of Industry Science and Resources

**Closing:** Ongoing

**Eligibility:** Australian State/Territory Government agency or body, an Australian local government agency or body/ a Regional University, an incorporated not-for-profit organisation

**Selection Process** Non-competitive (applicants will be assessed on their individual merit against the assessment criteria, and will not be compared to other applications)

The program will focus on a partnership approach to deliver investment in regional Australia. It will bring together governments and communities to plan and deliver regional precincts that are tailored to local needs and have a shared vision in how that precinct connects to the region. Partners can be from government, First Nations groups, community organisations, educational institutions, or private enterprise.

Regional precincts or 'places with a purpose' are user-defined geographic areas with a specific shared need or theme. Regional precincts may include business districts, neighbourhoods, activity centres, commercial hubs or community and recreational areas. They will be located in renewal areas and growth areas in regional centres, regional corridors, regional cities, as well as smaller town centres that serve as service hubs in more remote communities.

### **STREAM 1 funding amounts**

Precinct Development and Planning

- The minimum grant amount is \$500,000.
- The maximum grant amount is \$5 million.

The grant amount will be up to 100 per cent of the eligible expenditure for the project to a maximum amount of \$5 million.

### **STREAM 2 funding amounts:**

Shovel ready project

- The minimum grant amount is \$5 million.
- The maximum grant amount is \$50 million.

The grant amount will be up to 100 per cent of the eligible expenditure for the project to a maximum amount of \$50 million.

## Local Buying Foundation

**Agency:** BHP

**Closing:** 9 May 2025

**Eligibility:** Organisations / businesses located in the Council areas of Coober Pedy, Port Augusta, Port Pirie, Mount Remarkable, Northern Areas, Flinders Ranges. Outback Communities Authority, Whyalla and Roxby Downs.

The Local Buying Foundation is committed to supporting initiatives that strengthen local businesses, enhance industry capability, and drive economic growth.

Funds are allocated in alignment with the Foundation's priority focus areas. Funding applications are assessed against the Foundation's criteria.

**Funding Categories:**

- Business and Industry Innovation
- Workforce Development
- Indigenous Economic Development
- Micro-business and SME Capacity-building
- Industry Promotion and Economic Development

## PRIMARY PRODUCTION

### On-Farm Dry Times

**Agency:** Landscape South Australia Northern and Yorke

**Closing:** 2 March 2025

**Eligibility:** Primary producers that own or manage a primary production enterprise that is predominantly located within the Northern and Yorke Landscape Board region; and has received the majority (>50%) of income from primary production.

The On-Farm Dry Times Grants are designed to support the roll-out of sustainable agricultural practices for the longer-term viability of our region's farms.

The full list of activities can be found in the [Application Guidelines](#). They include:

- Installing new or repairing water infrastructure - pipes, pumps, irrigation, troughs and dams
- Constructing new or upgrading an existing stock containment area
- Accessing decision making tools - feed and soil tests, specialist dry times advice, soil moisture monitoring, weather stations, tank/trough monitors, telemetry sensor equipment

**What is available?**

The maximum funding (ex GST) available to primary producers depends on farm size.

Livestock and/or cropping enterprises:	Viticulture enterprises:
Up to \$3,000 for properties between 500-1000ha	Up to \$1,000 for properties between 10-25ha
Up to \$5,000 for properties 1000ha+	Up to \$3,000 for properties between 25-75ha
	Up to \$5,000 for properties 75ha+

### In a Good Place – Farming Communities

**Agency:** Foundations for Rural and Regional Renewal (FRRR)

**Closing:** Expressions of Interest are due by 14 February

Full applications submitted by invitation by 11 March

**Eligibility:** Applicant organisations must be a not-for-profit organisation with an ABN or Incorporation Certificate and benefit farming communities in remote, rural and regional areas with a high dependency on agriculture and related industries.

The In a Good Place program gives small remote, rural and regional communities across Australia the opportunity to access funds for a broad range of community-driven projects, services, activities or initiatives, which clearly and directly focus on strengthening mental health and wellbeing of vulnerable community members who are at risk of, or are experiencing, mental health issues.

The program supports community-based approaches that:

- are preventative or responsive in nature;
- focus on reducing mental health stigma and promote open discussions about mental health;
- encourage, support and enable people to seek help; and
- reduce social isolation by fostering social participation, inclusion and connection.

NOTE: Farming communities refers to remote, rural and regional communities with a high dependency on agriculture and related industries.

### On Drought Infrastructure Rebate Scheme

**Agency:** Government of South Australia - Department of Primary Industries and Regions

**Closing:** When funds are exhausted

**Eligibility:** Primary Producers

The Government of South Australia is offering a rebate of up to 75% to primary producers for implementing eligible on-farm infrastructure that enhances drought management and preparedness.

The On-Farm Drought Infrastructure Rebate Scheme aims to assist primary producers in implementing infrastructure projects that assist with managing current drought conditions and strengthen preparedness for future droughts.

Successful applicants must be able to cover the full cost of the infrastructure and will be reimbursed through the grant for 75% of the total cost up to a maximum grant of \$5,000 GST exclusive. Applicants must contribute at least 25% of the total infrastructure cost. Other government funding, including grants, concessional loans, or insurance claim funds, cannot be used towards the applicant's contribution.

Pre-approval of eligible activities for which costs are yet to be incurred may be obtained to provide certainty of receiving funding. Pre-approved activities must be completed within six months of the written pre-approval date.

The rebate is available for infrastructure activities that enhance drought management and preparedness:

- Costs associated with setting up or improving stock containment areas.
- Costs associated with the purchase and installation or upgrading of efficient water systems for irrigation.
- Costs associated with improving water infrastructure for livestock management.
- Costs associated with the adoption of technologies for improved drought management.
- Costs associated for labour of an external contractor to install, and repair or replace infrastructure set out in the eligible activities.

Only one application per ABN will be accepted.

### Connecting Communities Event Fund

**Agency:** Government of South Australia - Department of Primary Industries and Regions

**Closing:** 31 March 2025 or when funds are exhausted

**Eligibility:**

- Farmer groups, including Agricultural Bureau branches and farming systems groups
- Industry organisations
- Community groups such as agricultural show societies, progress associations, sports clubs, service clubs
- Local government.

Grants are available to host events that foster social connections and provide support to rural communities in South Australia affected by drought and other adversity. This initiative encourages communities to come together, share experiences, and reinforce the unity and strength of rural areas.

Grants up to a maximum of \$5,000 (GST exclusive) per event are available in the following categories:

- Medium to large scale community events that provide social connection, wellbeing or primary production resilience building activities and outcomes
- Community wellbeing and mental health development activities.

## On Farm Connectivity Program

**Agency:** Australian Government- Department of Infrastructure, Transport, Regional Development, Communications and the Arts

**Closing:** 30 April 2025

**Eligibility:** Primary Producers

The program assists Primary Producers to take advantage of digital agribusiness solutions to boost productivity and improve safety through Approved Suppliers.

The intended outcomes of the Program are:

- increase investment in equipment to support operations of the agricultural sector
- increase efficiency, competitiveness, and productivity of the agricultural sector
- improve safety on farm
- increase use of advanced farming technology
- improve knowledge of advanced farming technology and digital literacy

The rebate amount will be up to 50% of the cost of eligible equipment.

- the minimum grant (rebate) amount is \$1,000 (GST exclusive)
- the maximum grant (rebate) amount is \$30,000 (GST exclusive).

There is no limit to the amount an eligible Primary Producer may spend, however, the rebate cannot exceed \$30,000 (GST exclusive).

Primary Producers can purchase eligible equipment from multiple Approved Suppliers to a total combined value of \$30,000 (GST exclusive).

There are 5 broad categories of eligible connectivity solutions and associated eligible equipment:

- Low Power Wide Area Networks (LPWAN)
- Connectivity Equipment
- Environmental monitoring
- Farm management
- Remote automation and control

## Red Wine Grape Grower Support Grants

**Agency:** Government of South Australia – Department of Primary Industries and Regions

**Closing:** Ongoing

**Eligibility:** Growers who rely on agriculture for their primary source of income and derive 30% or more of their income from red wine grapes.

Wine grape growers across the state who are experiencing challenges due to the current oversupply of red wine grapes will be able to access additional support through Rural Business Support.

The support aims to alleviate stress for grape growers, who have felt significant impacts owing to market disruption, severe weather events and natural disasters.

**Amount:** Immediate grants will be available of up to \$1,500 to accommodate routine costs. This will be in conjunction with business financial counselling.

## COMMUNITY

### Social Impact Round Two

**Agency:** Government of South Australia – Department of Human Services

**Closing:** 17 March 2025

**Eligibility:**

- an Aboriginal Community-Controlled Organisation, or other Not-for-Profit Organisation
- a Social Enterprise that holds a current certification with Social Traders.

This funding round offers one-off grants up to \$30,000. Eligible organisations with annual reportable revenue <\$3m can apply by selecting one the following two tiers of funding.

- Tier 1 up to \$10,000 - To purchase equipment and resources, conduct community participation or inclusion activities and to improve or develop spaces for community participation.
- Tier 2 up to \$30,000 - For community development projects or short-term programs and minor infrastructure upgrades to improve access and inclusion.

Organisations can submit more than one application in Social Impact Round Two but can only be successful for one application in this round.

### Social Justice Small Grants Criteria 2025

**Agency:** Mercy Foundation

**Closing:** 4 April 2025

**Eligibility:** Local community groups and not-for profit organisations

The Mercy Foundation's Social Justice Small Grants Program provides seed funding to assist communities and organisations to build capacity that will help combat poverty and disadvantage, create structural change and bring about greater social justice in Australia.

The following criteria will be used to assess Social Justice Small Grant applications:

- Innovative projects that require seed funding to increase social equity and inclusion and challenge unjust structures and systems will be prioritised.
- The Mercy Foundation prioritises projects that target disadvantaged women and/or women with children.
- In this grant round, priority will be given to projects that promote the inclusion of marginalized groups in the community.
- Applications are accepted for projects that are run wholly within Australia, by community-based groups or organisations based in Australia.
- Organisations applying for funds must be a legal entity (or under an auspice organisation that is a legal entity), not-for-profit and therefore exempt from income tax, but are not required to have Deductible Gift Recipient status.
- Small to medium organisations with a turnover of less than \$3,000,000 with limited access to other funding sources are prioritised.
- Note that organisations with projects concerning homelessness should apply to the Mercy Foundation's Grants to End Homelessness program.

Grant amounts range from \$1,000 to \$10,000.

### Strengthening Rural Communities – Small and Vital

**Agency:** Foundation for Rural and Regional Renewal (FRRR)

**Closing:** Round 24: 27 March 2025

**Eligibility:** Local community groups and not-for profit organisations

Grants are available for a broad range of grassroots, community-led initiatives that directly and clearly benefit local communities that strengthen local people, places and climate solutions with a preference for smaller communities (populations under 15,000).

Priority will be given to projects that:

- Support communities to implement generational transition;
- Invest in outback, remote, and less-resourced communities;
- Build capacity and resourcing for a just and equitable energy transition; or
- Support First Nations-led initiatives that strengthen culture, country, economic participation and reconciliation.

Applications from sporting organisations need to clearly demonstrate charitable outcomes and benefit to the wider community that are above and beyond the sporting activities of the club.

Maximum grant is \$10,000

**NOTE:** There are two streams of funding available within the Strengthening Rural Communities (SRC) Program: Small and Vital and Prepare and Recover. Organisations may submit their application in one of these streams per SRC grant round, and any other applications in this round will be considered ineligible.

### Strengthening Rural Communities – Prepare and Recover

**Agency:** Foundation for Rural and Regional Renewal (FRRR)

**Closing:** Round 24: 27 March 2025

**Eligibility:** Local community groups and not-for profit organisations

This program supports communities in remote, rural and regional communities across Australia to implement initiatives that prevent and prepare for future climate related impacts, or recover from existing disasters in the medium to long-term timeframe, generally one to ten years after the disaster.

Priority will be given to projects that:

- Respond to a specific climate impact or event, either historic or likely to occur in the future;
- Focus on [community-led resilience building](#) in recovery or preparedness to strengthen the capacity and capability of local people and systems, especially to manage the impact of future disasters

- Invest in outback, remote and less-resourced communities where they may be more highly impacted by disasters;
- Support First Nations-led initiatives that strengthen culture, Country, economic participation and reconciliation;
- Support communities to implement generational transition; and
- Build capacity and resourcing for a just and equitable energy transition.

Maximum grant is \$25,000

**NOTE:** There are two streams of funding available within the Strengthening Rural Communities (SRC) Program: Small and Vital and Prepare and Recover. Organisations may submit their application in one of these streams per SRC grant round, and any other applications in this round will be considered ineligible.

### Naidoc Local Grants

**Agency:** Australian Government – National Indigenous Australians Agency

**Closing:** 20 February 2025

**Eligibility:** Aboriginal and Torres Strait Islander communities and supporting organisations

Grants are now available to celebrate NAIDOC Week (6 - 13 July 2025).

NAIDOC Local Grants provide a co-contribution towards the cost of NAIDOC activities and events.

Activities must align with the 2025 National NAIDOC Week theme “The Next Generation: Strength, Vision, Legacy” and celebrate First Nations histories, cultures, achievements and continuing contributions to our country and Australian society.

Events and activities could include:

- activities that promote healthy outcomes for First Nations people
- arts based activities, including design work, painting, dancing, crafts and storytelling
- family fun days
- cultural activities, including Welcome to Country
- Elders’ activities
- bush tucker and other community cooking activities
- NAIDOC themed sporting activities or competitions
- activities that actively promote reconciliation.

Most grants are expected to be awarded for \$10,000 or less. A small number of grants may be awarded for between \$10,001 and the maximum of \$25,000.

## SilverChef Community Grant

**Agency:** SilverChef

**Closing:**

Round 2: Applications open 1 October - 31 December

Round 3: Applications open 1 January - 31 March

Round 4: Applications open 1 April - 30 June

**Eligibility:** Non-For-Profit organisations

The SilverChef Community Grants Program is open to registered charities and not-for-profits that use hospitality or food service to support communities in need.

Four grants worth \$5,000 each are awarded each quarter globally. To be eligible, applicants should receive limited funding from other sources, have a clear and specific need for commercial kitchen equipment, and have been a registered charity or NFP for a minimum of 12 months.

Each \$5,000 grant is a 75:25 mix of equipment and cash.

## Strong and Resilient Communities (SARC) Inclusive Communities Grants

**Agency:** Australian Government – Department of Social Services

**Closing:** Round 4: 20 February 2025

**Eligibility:**

- Company
- Cooperative
- Incorporated Association
- Indigenous Corporation
- Local Government
- Statutory Entity
- Trust

Funding will be available to eligible organisations to deliver one-off time limited projects within their communities. Projects may include a trial, seed, or start-up project that aims to expand upon or reframe the delivery of existing activities, establish new activities, or deliver short-term interventions.

The project will aim to improve the social and economic participation of four target groups:

- young people aged 12 to 18 years who are, or are at risk of:
  - being disengaged or marginalised
  - having limited engagement with education/training
- people with disability
- women who are, or are at risk of, experiencing isolation or discrimination
- unemployed people who face individual barriers to employment.

The maximum grant amount is \$360,000 (GST exclusive), with a funding cap of \$180,000 (GST exclusive) per year for each grant.

The maximum grant period is 2 years.  
You must complete your grant/project by 30 June 2027.

### Variety SA Organisation/Community Grant

**Agency:** Variety the Children's Charity

**Closing:** Ongoing

**Eligibility:** Community organisation

Assistance is available for organisations supporting South Australian children aged up to 18 years of age, who are sick, disadvantaged or living with disability. To apply for assistance, you must be able to demonstrate a genuine need (including financial evidence) and information on how the assistance requested will meet this need.

A strong application will demonstrate the following:

- Unmet need i.e. it cannot be met through the organisation's own funding, through government or other organisation funding; and
- Direct benefit to the children in the care of the organisation.

### Connected Communities

**Agency:** Telstra

**Closing:** 20 March 2025

**Eligibility:** Community organisation

Telstra's Connected Communities Grant Program will boost support for communities across remote, rural and regional Australia to enhance liveability with digital solutions that harness the power of connection.

The program will support community-led efforts that embrace new technology and improve digital literacy or digital capability.

The program seeks to foster:

- Liveable communities that have digital capability, and help to equip individuals with the skills to live, learn and work in a digital society;
- Sustainable communities that are diverse and inclusive, planning for the health, wellbeing, and prosperity of their people and the planet; and
- Resilient communities that are well prepared and socially connected when disaster strikes with the ability to renew and recover together.

Grants up to \$10,000 are available for not-for-profit community organisations that are providing access to information, technology, education and facilities to support their communities to embrace new technologies and ways of working to build social capital and digital capability.

## AED Grant Program

**Agency:** Government of South Australia – Preventive Health SA

**Closing:** 30 April 2025

**Eligibility:** Community and sporting organisations

The State Government is improving access to Automated External Defibrillators (AEDs) by making them mandatory in certain buildings and facilities.

To support community and sporting organisations with the purchase of AEDs, Preventive Health SA is providing grants of \$1,000 per eligible location. All not-for-profit community or sporting organisations are invited to apply.

## Viterra's Community Sponsorship Program

**Agency:** Viterra

**Closing:** April 2025

**Eligibility:** Community and sporting organisations nominated by the grower

For every tonne of grain delivered on a contract, Viterra donates 20 cents to a registered community group or club nominated by the grower. This amount doesn't come from the grower's pocket – it's Viterra's donation to the community.

**For Growers:** When setting up contracts with Viterra, simply nominate a club or group you'd like to support. If you're working with an agent, they can do this on your behalf. Importantly, you don't need to be a member of the club to nominate it.

**For Clubs and Groups:** To benefit from this program, your group needs to register with Viterra and gain approval. Registered groups are then eligible to receive funds based on the total tonnage delivered by growers who nominate them.

Payments to clubs and community groups are made once a year, based on the total tonnage delivered under nominated contracts by the end of April.

**Agency:** Government of South Australia – Department of Premier and Cabinet

**Closing:** 2 March 2025

**Eligibility:** Multicultural organisations

The Stronger Together Grants support South Australian families and communities from culturally and linguistically diverse backgrounds to build resilience and become part of a strong and vibrant South Australian community.



The grants provide one-off funding to eligible multicultural organisations to develop projects that address priority needs and issues and improve outcomes for culturally and linguistically diverse communities.

Grants of up to \$200,000 are available for projects to be delivered over two years, commencing in July 2025 and concluding in June 2027.

### ABC Future Fund

**Agency:** ABC Foundation Ltd

**Closing:** Ongoing

**Eligibility:** Aboriginal organisations with an ABN from remote and regional areas.

Funding is available for projects aligned with the Future Fund focus areas, such as On-Country Education, On-Country Care, and On-Country Research & Development.

The fund also offers small one-off event grants of up to \$2,500 per applicant for community-centred activities.

### Inclusive Neighbourhoods

**Agency:** Julia Farr McLeod Benevolent Fund

**Closing:** Ongoing

**Eligibility:** Social purpose organisations (including not-for-profits, social enterprises, universities and governments) who demonstrate an existing commitment to inclusion through engagement of people with disability in recognised roles in governance and/or workforce.

This grant funds initiatives by organisations that develop policy or practice relating to the inclusion of people living with disability.

Grants can be used for

- Salaries and on costs
- Costs of setting up your project, such as recruitment and training
- General operating costs directly related to the project
- Organisation overheads related to the project – including management costs, office overheads, marketing costs etc
- Honoraria/gifts for people participating in the program, for example in governance, codesign, or advisory groups
- Event costs
- Marketing costs – this could include promotion of your project and reporting learning etc
- Monitoring and evaluation – we will arrange for a program-wide evaluation of learning and impact, but you should include any specific costs to your organisation in relation to, for example, collecting data
- Capital costs to support project delivery (e.g. laptops etc, rather than fixed assets)

**Amount:** Grants ranged in size between \$8,000 and \$230,000 in 2022- 2023  
Multi-year grants can be made available, up to a maximum of three years.

## VETERANS

### Veterans SA Commemorative Services Grant Fund

**Agency:** Government of SA – Veterans SA

**Closing:** 31 May 2025 unless funds exhausted prior to this date.

**Eligibility:**

- non-government, not-for-profit
- have a registered Australian Business Number (ABN)
- provide satisfactory evidence that the core purpose is to deliver initiatives, services or support for the South Australian veteran community
- be based in South Australia.

Funding can be used for eligible expenses that directly relate to coordination, management and delivery of commemorative services within South Australia.

Applicants can seek grants of up to \$1,000 (ex GST) for expenses that directly relate to the coordination, management and delivery of commemorative services within South Australia. A maximum of \$15,000 in grant funding is available for distribution in the 2024-2025 financial year.

Examples of eligible expenses include:

- venue (hire fees)
- equipment and furniture hire
- catering
- security
- advertising and marketing such as flyers, booklets and posters.

**Please note grants for Anzac Day Dawn Services are not available through this funding round.**

## SPORTS AND LEISURE

### Active State Collaboration Program (ASCP).

**Agency:** Government of South Australia – Office for Recreation, Sports and Racing

**Closing:** Midday 5 March 2025

**Eligibility:**

- be a not-for-profit, incorporated Association
- **OR** be a local Council; and
- have been operating for 12 months or longer.

Infrastructure projects (any facility upgrades and/or developments) are not eligible under this program  
The ASCP offers funding through two streams:

**Targeted stream (inactive youth):**

The targeted stream (inactive youth) will provide funding to projects that specifically encourage inactive youth aged 12 to 15 to adopt healthy physical activity behaviours.

Applicants applying for the targeted stream must demonstrate that the primary beneficiaries of the application are youth aged 12 to 15. Eligible projects may also have secondary beneficiaries that are outside of this cohort.

**Open stream (strategic)**

The open stream (strategic) is designed to support projects that align with the broader objectives of the ORSR Strategic Plan, focused on getting more South Australians moving.

This stream encourages innovative and inclusive approaches that inspire participation across all age groups, activity levels, and community settings, reflecting the diverse needs of South Australians.

The total budget for the 2024–2025 ASCP is \$2,380,000. \$1,850,000 will be allocated to the targeted stream (inactive youth) and \$530,000 allocated to the open stream (strategic).

**Eligibility:** community group, sporting club or not-for-profit organisation

National Pies will award a grant of \$1,000 each month until March 2025. They will also award a major grant of \$10,000 at the end of the program.

### Clubs for Communities – IGC Sponsorship

**Agency:** Clubs SA

**Closing:** Ongoing

**Eligibility:** Non-gaming sporting and community clubs

Projects must be accessible to people from across the State. One application per organisation will be considered in any twelve-month period.

Projects can be a "once off", or over a longer term.

Projects should reflect a high standard of integrity and identify the specific area of the community who will most benefit from assistance.

Preference will be given to causes that:

- can demonstrate assistance to those sectors in the community that are in some manner 'disadvantaged'. For example, priority will be given to projects that support children, young people, physically and/or intellectually disadvantaged people, health-related programs, and community-based projects by not-for-profit organisations.
- benefit a charity or community organisation directly, without going through an intermediary.

**Eligibility:** Disadvantaged communities

The Roger Rasheed Sports Foundation believes that regular sport activities and on-going training and mentoring can make a positive difference to children in all areas. By revitalising forgotten reserves and rusty old equipment or by building an entirely new precinct, the aim is to provide the children of extreme disadvantaged areas access to sport.

## Sports Vouchers

**Agency:** Government of South Australia - Office for Recreation Sports and Racing

**Closing:** Ongoing

**Eligibility:** For children living in South Australia in Reception to Year 9

The Sports Voucher program provides a discount of up to \$200 on sport, dance, learn to swim or scouts/guides fees for children living in South Australia in Reception to Year 9, each calendar year. The aim is to increase the number of children participating in physical activity by helping to reduce cost as a barrier.

## ARTS AND CULTURE

### Regional Event Fund

**Agency:** Government of South Australia - South Australian Tourism Commission

**Closing:** 18 March 2025

**Eligibility:** Individuals and groups. You must be an Australian citizen or an Australian permanent resident, and a practicing artist or arts professional.

The South Australian Tourism Commission's Regional Events Fund aims to strengthen the regional events calendar by encouraging the development of new and innovative regional events, grow existing events, and drive increased visitation and economic stimulus to the regional economy.

**There are two categories in the Regional Event Fund:**

#### Established Event Funding

Up to three years' funding will be provided to events that can demonstrate a strong track record of growth and a strategy for event innovation. Successful applications to the Established Event category will receive from \$20,000 up to \$50,000 per year in financial support.

#### Development Event Funding

Up to three years' funding will be provided to new and emerging events that can demonstrate potential for growth and development to become an annual addition to the event calendar. Successful applications to the Development Event funding will provide \$5,000 up to \$20,000 per year in financial support.

The Regional Event Fund supports events that:

- are leisure tourism events
- have a minimum of 500 attendees
- Generate event-specific visitor expenditure from intrastate and or interstate markets
- Are strategically important to their tourism region
- Align with the objectives in the South Australian Regional Visitor Strategy 2025

- Contribute to the cultural and social fabric of the region
- Are financially viable with a sustainable management model
- Relate to the state's tourism initiatives as highlighted in the South Australian Visitor Economy Sector Plan 2030

The following types of events are not eligible:

- Business events (conferences, seminars, expos, symposiums etc)
- Agriculture events
- Trade shows
- Award ceremonies
- Firework displays
- Anniversaries / centenaries, commemorative events
- Christmas Pageants
- South Australian rotational events
- Tours
- Open gardens / open days
- Dedicated markets/ fairs
- Reunions
- Charity events or fundraising activities

Established Event: between \$20,000–\$50,000 per year

Development Event: between \$5,000–\$20,000 per year

### Arts Projects for Individuals and Groups

**Agency:** Creative Australia

**Closing:** 4 March 2025

**Eligibility:** Individuals and groups. You must be an Australian citizen or an Australian permanent resident, and a practicing artist or arts professional.

This program funds a range of activities that deliver benefits to the arts sector and wider public, including national and international audiences and communities.

Grants are available from \$10,000 to \$50,000. Supported activities must not last longer than two years from the proposed start date.

Activities can include but not limited to:

- professional skills development, including mentoring and residencies
- the creation of new work
- practice based research
- creative development

- experimentation
- collaborations and exchanges
- touring
- festivals
- productions
- exhibitions
- performances
- publishing
- recording
- promotion and marketing
- market development activity
- activities that creatively engage communities.

### Arts Projects for Organisations

**Agency:** Creative Australia

**Closing:** 4 March 2025

**Eligibility:** Organisations that provide a service to the Arts

This program funds a range of activities that deliver benefits to the arts sector and wider public, including national and international audiences and communities. Organisations that undertake arts programs, projects, or that provide services to artists, are welcome to apply.

Organisations can propose a single project, a suite of projects or an annual program of activity.

Grants are available from \$20,000 to \$100,000. Supported activities must last no longer than two years from the proposed start date.

### Live Music Events Fund

**Agency:** Music Development Office – Government of South Australia

**Closing:** Ongoing EOI. Open each financial year until funds exhausted.

**Eligibility:** You must be a promoter, event organisation or music business (applicant) seeking financial support from the LMEF to present a major festival and music event (event) in South Australia.

The South Australian Government's LIVE MUSIC Events Fund (LMEF) was created to support live music events and festivals with the potential to grow into major tourist attractions. The Music Development Office (MDO), part of the Creative Industries team of Arts South Australia, at the Department of the Premier and Cabinet, administers the fund in consultation with Events South Australia, a division of the South Australian Tourism Commission (SATC). The Government has committed \$550,000 per year to support music events and festivals through the LMEF.

#### **Objectives**

The Live Music Event Fund aims to:

- elevate Adelaide’s recognition as a UNESCO City of Music through activating our live music events calendar
- mitigate the financial barriers experienced by promoters in the first two years of staging a new live music event
- attract unique music events to South Australia that generate economic benefit, provide local jobs for musicians and crews, and attract visitors from South Australia’s key domestic tourism markets
- provide industry development opportunities or pathways that support the growth of the event into a unique offering for the state that is financially sustainable and not reliant on government funding for viability.

## ENVIRONMENT

### The Seedling Bank Grant

**Agency:** National Tree Day

**Closing:** 28 February 2025.

**Eligibility:** Schools and Community Groups

The Seedling Bank program aims to supply native seedlings to schools and community groups across Australia. Financial grants are awarded directly to successful applicants. By addressing the specific needs of different regions, the Seedling Bank promotes biodiversity, ensuring our unique Australian landscape is restored.

### Heritage Grants

**Agency:** Government of South Australia- Department of Environment and Water

**Closing:** 31 March 2025.

**Eligibility:** Owners of State heritage listed places

Grants are provided for conservation work or documentation.

There are three categories of funding.

1. Simple- up to \$5,000 (GST exclusive) – Projects may include - Documentation, e.g. Architect fees, conservation management plans, dilapidation reports, development application drawings/schedules. Simple projects with only one component, e.g. Salt damp treatment or re-roofing.
2. Complex – up to \$10,000 (GST exclusive) – *THIS IS THE MAXIMUM AVAILABLE TO RESIDENTIAL PROPERTIES.* Projects for residential properties with multiple components such as reinstatement of lost significant fabric or larger, more complex repairs e.g. façade conservation including timber repair and salt damp treatment; roof and gutter replacement including new roof framing and fascias.



3. Major– up to \$20,000 (GST exclusive) - *ONLY AVAILABLE FOR NON-RESIDENTIAL PROPERTIES*. Projects for non-residential properties with multiple components addressing at least two of the Assessment Criteria, e.g. (1) Places at risk; (2) Adaptive re-use.

In most cases, grants will be provided on a dollar-for-dollar basis

### Bite-sized Grants Program

**Agency:** Northern and Yorke Landscape Board

**Closing:** 30 May 2025.

**Eligibility:** Incorporated not-for-profit groups including, but not limited to Land, Coast, and Bushcare groups, Friends of groups, farming groups and schools.

Eligible projects will contribute to one or more of the priorities of the Northern and Yorke Landscape Board:

- Pest Plant and Animal Control
- Sustainable Agriculture
- Water Management
- Biodiversity
- Communities

Grants are available between \$200 and \$2,000 for on-ground activities such as weed control, revegetation, watercourse restoration, community education, erosion and pest management.

There is a limit of one successful application per group.

Individual landholders cannot apply, although groups of landholders may apply with the support of a sponsor.

### Clare and Gilbert Valleys Council Community Donation

**Closing:** Ongoing

**Eligibility:** Community Organisations / Charitable Organisations / Special Needs Groups from the Council area

The Community Donation program provides various forms of support, including donations, grants, interest-free loans, and in-kind assistance, to ensure that community-driven projects, and initiatives receive the necessary resources.

It encourages community groups to partner with Council to deliver positive outcomes that benefit the region. Preference is given to local applicants or initiatives that offer direct and benefits to the community. Maximum amount \$3,000.

### Clare and Gilbert Valleys Council Special Events

**Closing:** Ongoing

**Eligibility:** Community Organisations / Charitable Organisations / Special Needs Groups from the Council area

For special community events that have a direct benefit to the local community

These events are classified as “Local Events” being events that are private, small in attendance, primarily local visitors eg: street parties, country markets, Christmas functions, organised and managed locally. Maximum amount \$5,000

### Port Pirie Regional Council Community Assistance Fund

**Closing:** Ongoing (Four rounds per year)

**Eligibility:** Non-for-profit organisations, community and sporting groups based in the Council area

The purpose of the fund is to encourage and support community initiatives that respond to local needs, enhance community well-being and quality of life and are of benefit to the residents.

It is aimed at providing non-for-profit organisations, community and sporting groups based in the Council area with the opportunity to obtain funds for projects or events which cannot easily be obtained from other sources.

Grant funding of up to a maximum of \$4,000 is available for financial and/or in-kind assistance per application, per organisation, per year.

Applicants may submit one application per funding round.

### Regional Council of Goyder Community Events Funding

**Eligibility:** Events held within the Council area

Community event funding is available to support events held within the Council area, with broad appeal to both the local and wider community that celebrate significant occasions, encourage cultural diversity or bring communities together.

An [Event Management Plan](#) will need to be provided as part of the application.

This funding is available throughout the year (unless funds for that financial year are exhausted) and will be presented for consideration at the relevant Council meeting.
